Other Contributions

These outlets include refereed journals that are not included in the above lists but still provide exposure. At some point it becomes difficult to explicitly note a meaningful list of C journals and differentiate them from D journals or even lower categories of contribution. By not providing a specific list, we are not arguing that any contribution not on the above lists counts as a C. We are arguing that publications in other refereed journals that do not rate being specifically included in the A+, A, or B lists do indicate a contribution and should be recognized, but it is difficult and probably not useful to draw fine distinctions among them. Publications in journals that are not on the lists, but that the author feels warrant being counted as an A+, A, or B, can be submitted to the review process noted above. Publications in non-refereed journals would typically count less than those in refereed journals, although these can be submitted for review if the author thinks they warrant different treatment.
