## **College of Education**

The <u>College of Education</u> is responsible for the coordination of teacher licensure programs for the University of Memphis.

All the professional licensure programs are approved by the <u>Tennessee State Department of Education</u> and are nationally accredited by the <u>Council for the Accreditation of Educator Preparation (CAEP)</u>. Graduates are qualified to apply for licensure in Tennessee.

Graduates are also qualified for licensure in many, but not necessarily all, other states and territories. Teaching licensure reciprocity is complicated, and states often have additional requirements that must be fulfilled at the time of licensure or within the license renewal cycle when moving to a new state.
